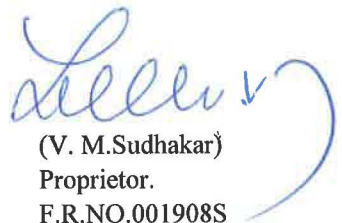
Further, we report that:
